#### ORDER

#### The 21st November 1994

S,R.O. No. 1111/94—In exercise of powers conferred by sub-section (4) of section 7-C of the Orissa Education Act, 1969 the State Government do hereby make the following Order to regulate payment of grant-inaid to private educational institutions or for any post or to any person employed in such institution being a son-Government College, Junior College or Higher Secondary School as specified hereunder, namely :—

1)(1) This Order may be called the Orissa (Non-Government Colleges, Junor Colleges and Higher Secondary Schools) Grant-in-aid Order, 1994.

(2) It shall apply to the Non-Government Colleges, Junior Colleges and Higher Secondary Schools.

(3) This Order shall come into force with effect from the date of its publication in the Official Gazette.

2. (1) In this Order, unless the context otherwise requires,-

(a) "Act" means the Orissa Education Act, 1969, (Orissa Act 15 of 1969) :

(b) "Amendment Act" means the Orissa Education (Amendment) Act, 1994 (Orissa Act 12 of 1994);

(c) "Council means the Council of Higher Secondary Education, Orissa. constitued under the Orissa Council of Higher Secondary Education Act. 1982;

(d) "Category" means the category of Non-Government Educational Institutions as made in paragraph-4 of this Order;

- (e) "Director" means the Director, Higher Education, Orissa and includes any officer not below the rank of Deputy Director who may be authorised by the State Government in that behalf from time to time by a general or a special order to perform all or any of the functions and exercise all or any of the powers of the Director under this Order;
- (f) "Educatioanly Backward District" means as district where percentage of literacy is less than 50 per cent of the total population of the district as per the latest Census;
- (g) "Government" means the Government in the Department of Higher Education ;
- (h) "Governing Body" means a Governing Body constituted in accordance with the Act and the Orissa Education (Establishment, Recognition and Management of Private Colleges) Rules, 1991 or the Orissa Education (Establishment, Recognition and Management of Private Junior Colleges/Higher Secondary Schools) Rules, 1991, as the case may be;
- (i) "Non-Governnment Educational Institution" means any educational institution which is not established and/or managed by Government of Orissa, the Union Government or the Government of any other State and does not include for purposes of this Order, any educational institution established or managed by any Corporation, Municipality or Notified Area Council, Zilla Parishad, Panchayat Samiti or any Grama Panchayat or any Public Sector Undertaking or Company or Statutory Body; and

- (j) "University" means the Utkal University, the Berhampur University or the Sambalpur University, as the case may be.
   All other words, and expressions used, but not defend in the set of the set
- (2) All other words and expressions used but not defined in this Order, unless the context otherwise, requires shall have the same meaning as respectively assigned to them in the Act.
- 3) The following categories of Non-Government Educational Institutions shall only be eligible for consideration for being notified as Aided Educational Institution :--
  - Higher Secondary Schools or Junior Colleges recognised by Government and affiliated to the Council imparting instructions and presenting regular candidats for Higher Secondary Examinations in Arts, Science or Commerce streams conducted by the said Council.
  - (2) Colleges recognised by Government and affiliated to any of the Universities imparting instructions and presenting regular candidates for the B. A., B. Sc. or B. Com. Degree Examinations of the Utkal, Berhampur and Sambalpur Universities, with or without Honours.
- Nore-"Sanskrit Tols, by whatever rame called, conducting Upasastri, Sastri or Acharya Courses of Shree Jagannath Sanskrit University shall not be covered by this Order".
  - (3) No Non-Government Educational Institution imparting any courses of study other than those specified in Sub-Paras. (1) and (2) of this Para. shall be eligible to be notified as an Aided Educational Institution or to receive grant-in-aid from Government for any post in such institution.
  - (4) Notwithstanding anything contained in Sub-Paras. (1) and (2) of this Para. no educational institution established or managed by any Corporation, Municipality or Notified Area Council, Zilla Parislad. Parchayat Samiti or any Grama Panchayat, any Public Sector Undertaking or Company or Statutory Body, the Union Government or the Government of any other State shall be deemed to be a Non-Government Educational Institution for the purposes of this Order and no such educational institution shall be eligible to be notified as on Aided Educational Institution or treceive grant-in-aid for any post from the State Government under this Order.
  - (5) No order according permission or approval or recognition either temporary or otherwise under the relevant provisions of the Act, or under any Rule applicable to it, and no order of any University or the Council according affiliation, whether such permission, approval, recognition or affiliation was accorded prior to the commencement of the Amendment Act, or thereafter shall ipso facto entitle any Non-Government Educational Institution to be notified as an Aided Educational Institution or to receive grant-in-aid for any post.

(4) For the purposes of this Order, Non-Government Educational Institutions specified in Sub-Paras. (1) and (2) of Para. 3 and the posts in such institutions shall be classified into the following categories namely:—

- A-Category I (i) Non-Government Educational Institutions and approved posts in such institution which have received grant-in-aid from Government or in respect of which grant-in-ain has been sanctioned by Government prior to the commencement of the Amendment Act,
  - (ii) Other posts in Non-Government Educational Institutions covered under Category-I (i) which were admissible on the basis of workload and prevalent yardstick and had been filled up prior to commencement of the Amendment Act, but in respect of which no grant-in-aid had been sanctioned.
    - Nore—If a question arises whether a post was admissible on the basis of workload prevalent yardstick, the decision of the Director shall be final.
- B-Category II (i) Colleges imparting instructions in and presenting regular candidates for the B. B. Sc. or B. Com. Examinations with or without Honours of any of the Universities have been functioning regularly for five years or more by the 1st June 1994 obtaining Government concurrence or recognition and affiliation of any Unive or for three years or more if such institution is located in an educationally back district, which has not been notified as an Aided Educational Institution and has received grant-in-aid from Government for any post.
  - (ii) Higher Secondary Schools and Junior Colleges conducting courses in Arts, Science and Commerce which have been functioning regularly for 5 years or more by the 1st June 1994 after obtaining Government concurrence or recognition and affiliation of the Council, or for 3 years or more if such an institution is located in any educationally backward district, but which have not been notified as Aided Educational Institution and have not received grant-in-aid from Government for any post.

-Category III Non-Government Educational Institutions of the cotegories specified in Sub-Paras. (1) and (2) of Para. 3 which have already been established and have received recognition of Government and affiliation prior to the commencement of the Amendment Act but do not come within Categories I or II of this paragraph, and such institutions which may be established and granted recognition by Government under the Act or the provisions made thereunder and affiliation by the University or the Councill, as the case may be, after the commencement of this Order.

5.)(1) All Non-Government Educational Institutions included in Category I (i) of Para. 4 shall be deemed to be Aided Educational Institutions for purposes of this Order.

- (2) No Non-Government Educational Institution falling within Category II or Category III of Para. 4 shall be eligible to be notified as an Aided Educatic nal Institution under this Order unless it has fulfilled the following conditions, namely :--
  - (A) (i) An institution being a Non-Government Educational Institution falling within Category II, has been functioning on a regular basis after receiving recognition from Government and affiliation from the concerned University or the Council, as the case may be, for 5 years or mare, or for 3 years or more if such educational institution is located in an educationally backward district, prior to 1st day of June, 1994.
    - (ii) An institution being a Non-Government Educational Institution falling within Category III has been established and has been functioning on regular basis after receipt of recognition and affiliation for a qualifying period of five years:

Provided t that the qualifying period shall mutatis mutandigst be three years if such an institution is located in an equcationally backward district or is a women's educational institution imparting education exclusively to women.

NOTE : For the purposes of this Order, no educational institution shall be deemed to be a women's educational institution unless it has received recognition and affiliation as such and any such institution shall seased to be a women's educational institution if subsiquently it is converted into a co-educational institution. In the event of such conversion, the notification declaring it to be an Aided Educational Institution, if any, shall be modified.

- (iii) Notwithsthstanding anything contained in this Order, no Junior College or Higher Secondary School or College, as the case may be, falling under Category III shall be eligible to be notified as an Aided Educational Institution if,—
- (a)] in the case of a Junior College or a Higher Secondary School, there are already two aided Junior Colleges/Higher Secondary Schools in that Block or if the institution is located within an urban area, there are more Aided Higher Secondary Schools/Junior Colleges than one for every 50,000 population subject to a minimum of one.
- (b) in case of a College, there is already one aided Degree College in that Block or if the Institution is located in an urban area, there is one Aided College for every one lakh population subject to a minimum of one.

NOTE—An educational institution conducting B. A., B. Sc. or B. Com. Degree Courses and Junior College or Higher Secondary Courses shall, for the purposes of this Para., be treated as two separate institutions.

#### Illustrations :-

- (1) A Non-Government Junior College falling under Category III named 'X' otherwise eligible to be notified as an Aided Educational Institution completes the qualifying period of 5 years on 31-5-1995. One Junior College and one Higher Secondary School situated in the same Block have been notified as Aided Educational Institution with effect from 1-6-1994. Junior College 'X' cannot be notified as an Aided Educational Institution as there are already 2 Aided Junior College/Higher Secondary Schools in that Block.
- (2) A Block already has one aided Degree College duly notified with effect from 1-6-1994. One Degree College and one Higher Secondary School otherwise eligible for being notified as Aided Educational Institution complete the qualifying period of eligibility on 1-6-1995. Since the Block already has one Aided Degree College no other Degree College would be eligible to be notified as Aided Educational Institution, But since there is no Aided Junior College in that Block, the Junior College will be eligible to be notified as such from 1-6-1995.

- (3) A Block has two Junior Colleges which are deemed to have been notified as Aided Educational Institutions prior to 1-6-1994. Subsequently a College called 'X' which conducts both Higher Secondary Course and Degree Course is Established and completes the qualifying period of 5 years on 1-6-1995. Since there are already two Junior Colleges in that Block, the Higher Secondary Wing of the College 'X' will not be eligible to be notified as Aided Educational Institution but since the Block has no Aided Degree College, the Degree College Wing of College 'X' will be eligible to be notified as Aided Educational Institution.
- (4) A College in a Block conducts both Higher Secondary Course as also Degree Course. Both the Higher Secondary and the Degree Wings have been separately notified as Aided Educational Institutions. Another College with both Higher Secondary and Degree Wings has been established and completes the qualifying period of 5 years. The Higher Secondary Wing of the latter college alone will be eligible to be notified as an Aided Educational Institution.
- (5) An urban area having a population of 51,000 has already one Aided Junior College. No further Junior College would be eligible to be notified as Aided Educational Institution till the population of that urban area exceeds one lakh.
- An urban area with a population of two lakhs fifty thousand already has 3 Aided Degree Colleges prior to commencement of this Order. No more Degree College would be (6) eligible to be notified as Aided Educational Institution in that urban area till the population exceeds 4 lakhs.
- (7) An urban area has a population of 27,000. One Junior College/Higher Secondary School and one Degree College would be eligible for being notified as Aided Educational Institution if there is no Aided Junior College/Higher Secondary School and no Aided Degree College in that urban area.

(iv) Notwithstanding anything contained in this Order, if no Women's Junior College/Higher Secondary School or no Women's College has been notified as an Aided Educational Institution or k. cellege School or no Wom no such institution Rev. Sub-Oie State Government do not exist in no such institution is eligible to be notified as such within a revenue Sub division and the adequate facilities for do not exist in that Sub-division, the State Government may notify not more than one Women's Junior College/Higher Secondary School and one Women's College as the case may be, as an Aided Educational Institution in addition to the number of institutions eligible under Sub-Para. (2) (A) (iii) of this Para. subject to such institution being otherwise qualified to be notified as such.

Illustrations.

(1) A Revenus Sub division has three Blocks and each Block has one Aided Degree College and two Aided Junior Colleges/Higher Secondary Schools. None of these Aided Educational Institutions is a Women's College or a Women's Junior College/Higher Secondary School. One Women's Degree College and one Women's Junior College/Higher Secondary One Women's Degree College and one Women's Junior College/Higher Secondary School may be notified as Aided Educational Institutions in this Sub division subject to it being otherwise eligible even though the limit on the number of Aided Educational Institutions may be exceeded.

A Revenue Sub division has three Blocks and each Block has one Aided Degree College and two Aided Junior Colleges/Higher Secondary School. One of these aided institution is a Women's Junior College. Since the Sub division has no Aided Women's Degree College one Woman's Degree College may be notified as an Aided Educational Institution subject to its eligibility even though the limit on the number of Aided Degree College may be exceeded.

- (v) Where the number of Non-Government Institutions eligible to be considered during an academic year for being notified as Aided Educational Institution is more than the mumber of such institutions that may be notified under this Order, the Director shall select the educational institution/institutions which serve the educational needs of that area the best for being so notified and for doing so shall have regard to the following, namebly :-
  - (a) Average enrolment during the three preceeding years;
  - Average number of students presented for examinations conducted by the University, (b) Council during the preceding three years;
  - (c) Performance of the institution in the examinations conducted by the Council/University;
  - (d) Availability of infrastructural facilities including Library and Laboratory facilites;
    - (e) Maintenance of dicipline and academic standards in the educational institution;
  - (f) Availability of Government or Aided Educational Institution nearby;

(B) The educational institution has maintained throughout the qualifying period the required student strength as provided under Section 11 of the Act.

(C) The educational institution has admitted students regularly during each academic year within the qualifying period for eligibility and such admissions have been made on merit :

Explanation—In determining merit, weightage given for admission to Government Colleges may be taken into accoun. Merit of students belonging to a reserved category shall mean *inter se* merit within that reserved category.

- (D) The educational institution has been imparting instuction regularly in accordance with the instruction regulations of the University or the Council, as the case may be, and has maintained proper standard of teaching and discipline.
- (E). The Educational Institution has appointed adequate number of teachers and no person who is not qualified to be so appointed has been appointed as a teacher or against any non-teaching post.
- (F) Teachers and non-teaching employees have been recruited and appointed in accordance with the procedure applicable.
- (G) Percentage of students passing the Annual and Supplementary Examinations conducted by the Council or the concerned University, as the case may be, from the College or Junior College/ Higher Secondary School does not fall short of half of the percentage of students passing such examination for the entire Council or the University, as the case may be, for three consecutive years immediately preceding the date of eligibility:
  - Provided that where an College or Junior College or Higher Secondary School has not been able to present three consecutive batches of students in the Annual and Supplementary Examinations conducted by the Council or the concerned University may be provisionally notified as an Aided Education Institution, if the results during the years that candidates were presented did not fall short half of the percentage of students passing such examination of the entires Council or University, as the case may be, the provisional notification shall either be withdrawn or made final after the Institution presents three consecutive batches of students for such examination. When any Educational Institution has been provisionally notified as an Aided Educational Institution. the eligibility of admissible posts in such institution to receive grant-in-aid shall also be provisional.
- (H) The Educational Institution has not refused to conduct any examination or examinations of the Council, the University and of any other examining body of the State.
- (I) The Principal, teachers and non-teaching employees of the Educational Institution have performed their examination duties in respect of examinations conducted by the Council, the University and any other examining body of the State fairly and properly and no employees of the Governing Body of that institution has been found to have assisted or abetted in adoption of malpractices or to have failed in preventing malpractices in such examination at any time.
- (J) The Governing Body of the Educational Institution has not adopted unethical personnel policies or practices.

#### Illustrations-

- (1) A College appointed 'X' a duly qualified candidate as a Lecturer after due selection and in accordance with the prevalent rules and instruction. His services are terminated without valid or lawful reasons just before the post held by him acquires eligibility for receiving grant-in-aid. Such an action of the Governing Body would be treated as an unethical practice.
- (2) 'A' is appointed as a Lecturer in a College after due process of selection. Two years later 'B is appointed as Lecturer in the same subject. On assessment of workload, it is found that only one post is admissible in that subject. The College does not recommend the name of 'A' but recommends the name of 'B' for receiving grant-in-aid against the admissible and eligible post. Such a practice would be treated as unethical.
- (K) The educational institution has received recognition and affiliation for each course, streams and subject taught in that institution for each academic year within the qualifying period without any break or discontinuity.
- (L) The Educational Institution has maintained correct records of admissions, attendance of students accounts of receipts and expenditure and acquittance rolls of salary and other allowances paid to teaching and non-teaching employees of the institution.

- (M) The educational institution has a Governing Body duly constituted and approved in accordance with the relevant rules.
- (N) The Governing Body of the educational institution has submitted an application in the prescribed form complete in all respects within the period specified and in accordance with the procedure laid down in this Order:
- (O) The educational institution has fulfilled all the critreia and the Director has recommended notification of such institution as an Aided Educational Institution.
- 6. A Non-Government Educational Institution found eligible under Para. 5 shall be notified to be Aided Educational Institutions by Government. No. education institution which has not been notified by the Stat. Government as an Aided Educational Institution under the Act and no post in any such, institution shall either be eligible to receive or receive grant-in-aid from Government.

7.(1) A Non-Government Educational Institution eligible to be and desirous of being notified as an Aided Educational Institution shall make an application to the Director in the Form 'A' appended to this Order as Annexure-I together with copies of documents specified therein within such period as specified hereinafter. The application shall be made and signed jointly by the President and the Secretary of the Governing Body and shall inter alia be accompanied by:—

- (i) an affidavit attesting to the correctness of the facts and statements made in the application and authenticity of copies of documents attached thereto:
- (ii) an undertaking supported by a Resolution of the Governing Body to the effect that the Governing Body agrees to the grant-in-aid as may be admissible and sanctioned for the purpose of meeting any part of the salary cost of the employees of that Institution being disbursed directly to the employees concerned by the Director or any agency authorised by Government agreeing to adjustment by the Director if any excess or in-admissible grant-in-aid payments that may have been made at any time from subsequent grant-in-aid payments and agreeing to refund to Government any amount that cannot be adjusted within three months of reccipt of information regarding refund; and
- (iii)) a resolution of the Governing Body requesting Government to notify the applicant institution as an Aided Educational Institution and agreeing to abide by the previsions of this Order and also to such conditions as may be specified for sanction and utilisation of grant-in-aid.
- (2) An application under Sub-Para. (1) shall be made within three months from the date of completion of the qualifying period of eligibility. The Director may for good and sufficient reasons extend the period within which the application may be made by such period as he deems fit but not exceeding six months in the aggregate. No application received thereafter shall be taken into consideration :
- Provided that any Non-Government Educational Institution which has completed the qualifying period of eligibility prior to commencement of this Order may submit the application under sub-para (1) within two months from the date of publication of this Order in the Official Gazette.
- (3) On receipt of an application, the Director shall inspect or cause the Applicant Educational Institution to be inspected and take such measures as may be necessary to satisfy himself about the eligibility or ineligibility of that Educational Institution for being notified as an Aided Educational Institution. The Director may cause the accounts of the Applicant Institution to be audited and call for such further records, documents and evidences as in his opinion are required for establishing the eligibility of the Applicant Institution for being notified as an Aided Educational Institution.
- (4) After completion of his enquiry, the Director shall report to the State Government the facts and circumstances in which the applicant institution has been found eligible or not eligible and shall also make recommendation in respect of each applicant.
- (5) If on receipt of the recommendation of the Director and in consideration of the facts and circumstances reported, the State Government are satisfied that the applicant educational institution is eligible to be notified as an Aided Educational Institution they shall issue a notification to that effect specifying the date from which the institution shall be treated as an Aided Educational Institution. The State Government may also call for such further information, records and documents and order further inspection or audit of the accounts of the institution as may be required for satisfying themselves about the eligiblity of the applicant.

8.) A Non-Government Educational Institution which has been notified as an Aided Educational Institution shall not *ipso facto* be eligible to receive grant-in-aid. Such an institution will only be eligible to receive grant-in-aid towards salary cost of teaching and non-teaching posts in that institution which are eligible to receive grant-in-aid in accordance with the provisions of this order.

- 9.(1) A teaching or a non-teaching post in a Non-Government Educational Institution coming under Category-I in respect of which grant-in-aid has been sanctioned at any time prior to the commencement of the Amendment Act shall be deemed to be an approved posts for the purpose of this Order.
  - (2) A teaching or a non-teaching post not covered by Sub-Para. (1) of this Para. shall be treated as admissible and shall be eligible for approval subject to satisfying the following conditions:-
  - (A) The post in respect of which approval is sought is a post in an educational institution which has been notified as an Aided Educational Institution.
- (B) (i) A post in a Non-Government Educational Institution coming under Category-I for which no grant-in-aid has been sanctic ned prior to commencement of the Amendment Act, if—
- (a) the post was admissible as per work-load and yardstick prevalent prior to commencement of the Amentment Act;
- (b) has been filled up prior to that date, and,
- (c) it has completed the qualifying period of five-years or more, or of 3 years or more in case the institution is situated in backward area.
- (ii) A post in a Non-Government Educational Institution coming under Category II, if-
  - (a) the post was admissible as per workle ad and yardstick prescribed in this crder vide Arneyure III,
  - (b) has been filled up prior to commencement of the Amendment Act, and
  - (c) it has completed qualifying peried of 5 years or more, or of 3 years or more in case that institution is situated in an educationally backward district.
- (iii) A post in an educational institution coming under Category III on a post in institutions coming under Categories I and II which do not come within clauses (B) (i) and (B) (ii) of Sub-Pera. (2) of this Para. if—
- (a) the post is admissible as per work-load and yardstick prescribed in this order, and
- (b) it has completed qualifying period of 5 years or more from the date of its admissibility or of 3 years or more in the case of an educational institution situated in an educationally backward district or is a Women's Educational Institution.
- (C) The work-load for determining admissibility of a post shall be computed by taking into account the total work-load on account of Degree course and Higher Secondary course in all streams conducted in that institution. If a question arises as to whether a post is admissible on the basis of work-load and/or yardstick, the decision of the Director thereon shall be final.
- (D) The work-load shall be determined with reference to the actual enrolment during the academic year in which the post is admissible, limited to the strength of students for which recognition and affiliation has been received and the number of candidates presented at the Higher Secondary or the Degree examination, as the case may be, from the same batch of students.
- (E) A post shall not be deemed to have completed the qualifying period unless—
  - (i) the post has been filled up on full time basis during the entire qualifying period;
  - (ii) the post has not been filled up on honorary or part-time basis at any time during the entire qualifying period;
  - (iii) the post has been filled up by a person recruited in accordance with the procedure laid down in the Act, Rules and instructions as applicable at the relevant time;
  - (iv) the post has been filled up at all times during the qualifying period by a person duly qualified to hold such a post.
  - Note—'Duly qualified' means a person possessing the minimum qualification and experience prescribed for the post at the time when the post was admissible or on the date recruitment was made whichever is later.

(E) If any post admissible on the basis of work-load and yardstick has not been filled up in the manner indicated in clause (E), the period during which the post was not filled up in such manner shall not count towards computation of the qualifying period.

Illustration—A post of a Lecturer is admissible on the 1st June 1985. Since the college is not situated in an educationally backward district it would ordinarily have completed the qualifying period on the 31st May 1990. It is found that this post was not filled up by the management for 6 months, was filled up by an under qualified person for 4 months and was filled up by a Lecturer on part-time basis for 2 months. This period of 12 months shall not count towards qualifying period. The post would now be eligible for approval with effect from the 1st June 1986 and for grant-in-aid with effect from the 1st June 1991.

(G) An application has been made for approval of the post in the manner laid down

(3) Application for approval of posts which are eligible for approval by that date and application for notification of that educational institution as an Aided Educational Institution shall be made simultaneously in Form 'A'. Application for approval of any post which becomes eligible for approval thereafter shall be made in Form 'B' prescribed in Annexure II within three months from the date of its eligibility for approval. An application received in Form 'B' shall be dealt with in the manner laid down in para. 7. Where the Director is satisfied that a post is eligible for approval, he shall issue an order to that effect with prior concurrence of State Government indicating the date from, which the post has been approved and the date of eligibility of that post to receive grant-in-aid.

(4) (i) The date of eligibility of a post in respect of which grant-in-aid has been sanctioned Prior to commencement of the Amendment Act shall be the date on which the posts were admitted to the fold of grant-in-aid for the first time.

(ii) The date of eligibility of a post for which grant-in-aid has not been sanctioned shall be the first day of the academic year following the date on which an approved post completes the qualifying period as applicable to the post:

Provided that the date of eligibility in respect of a post in an educational institution coming within category II or III shall in no case be a date prior to 1-6-1994.

(10) (1) Grant-in-aid payable to an Aided Educational Institution shall be the sum total of grant-in-aid admissible towards salary cost at rates specified below for each admissible and approved post from and after the date of eligibility and the grant-in-aid so payable shall be disbursed directly to the incumbents validly appointed and holding the post eligible for grant-in-aid, either by the Director or through any other agency so authorised by Government. Government may from time to time determine the mode and form of disbursement:

Provided that Government may require that any part of the grant-in-aid payble as arrears shall be deposited in the provident fund or that it may be paid in some other form.

- (2) Grant-in-aid for a post in a Non-Government Educational Institution coming urder Category I in respect of which grant-in-aid has been sanctioned at any time prior to the commencement of the Amendment Act shall continue to be paid at the rate at which grant-in-aid was admissible on the date of commencement of the Amendment Act and such a post shall also be eligible to get grant-in-aid at the rate of 2/3rd of the approved salary cost 2 years after the date of receipt of grant at the rate of 1/3rd and at the rate of full admissible salary cost 2 years thereafter, if not already paid at such rates :
- (3) A post in an Aided Educational Institution coming under Category-I for which no grant-in-aid has been sanctioned prior to commencement of the Amendment Act shall be eligible to receive grant-inaid at the rate of 1/3rd of the admissible salary cost from the date of eligibility, at the rate of 2/3rd of the admissible salary cost 2 years after receipt of grant-in-aid at the rate of 1/3rd and at the rate of full admissible salary cost 2 years thereafter.
- (4) (i) A post in an Aided Educational Institution belonging to Category II and the date of approval of which falls on any date prior to the 1st June 1994 shall receive grant-in-aid at the following rate:—
  - (a) A post which has completed five-years by the 1st June 1994 but has not completed seven years from the date of its approval shall receive grant-in-aid at the rate of  $\frac{1}{3}$ rd of the salary cost at the initial of the scale applicable to the post with effect from the 1st June 1994.
  - (b) A post which has complated seven years by the 1st June 1994 but has not completed nine years from the date of its approval shall receive grant-in-aid at the rate of 2/3rd of the salary cost at the initial of the scale with effect from the 1st June 1994.

- (c) A post which has completed nine years by the 1st June 1994 from the date of its approval shall receive grant-in-aid at the rate of full salary cost at the initial of the scale with effect from the 1st June 1994:
  - Provided that a post in an Aided Educational Institution under Category II which is located in an Educationally Backward District shall irrespective of the date of its approval receive grant-in-aid from the 1st June 1994 at the rate of  $\frac{1}{3}$ rd of the salary approval receive grant-in-aid from the fst June 1994 at the rate of 3rd of the salary cost at the initial of the scale applicable to the post if it has completed three years but has not completed five-years, at the rate of 2/3rd of the salary cost at the initial of the scale applicable to the post if it has completed five years but has not completed seven years at the rate of full salary cost at the initial of the scale applicable to the post if it has completed seven wars or by the let line 1004 from the date of its approval. years or by the 1st June 1994 from the date of its approval.
- (ii) No grant-in-aid shall be payable for any admissible post in an Aided Educational Institution included in Category II irrespective of the date of its approval for any period prior to 1-6-1994.
- (iii) A post in an Aided Educational Institution included in Category II which receives grant-in-aid at the rate 1/3rd or 2/3rd as the case may be of the salary cost from 11-6-1994 shall be eligible to receive grant-in-aid at the rate of 2/3rd of the admissible salary cost two years after receipt of the grant-in-aid at the rate of 1/3rd and at the rate of full admissible salary cost two years after receipt of grant-in-aid at the rate of 2/3rd.
- (5) A post in an Aided Educational Institution included in Category III shall be eligible to receive grant in-aid at the rate of 1/3rd of the rate of 1/3rd of the admissible salary cost from the date of eligibility at the rate of 2/3rd of the admissible salary cost 2 years thereafter and at the rate of full salary cost 2 years after receipt of grant-in-aid at the rate of 2/3rd.
- 1) Admissible salary cost for the purpose of computation of grant-in-aid payable against any post shall mean pay at the lowest stage in the scale of pay with one increment for each completed year of service after the date of commencement of payment of grant-in-aid and shall include D. A. at the rates made applicable by the State Government from time to time. The scale of pay for the purpose of computation of grant-in-aid shall mean a scale of pay prescribed by the State Government for Non-Government Institutions for that post. Provisions of the Orissa Service Code relating to grant of increment shall mutatis mutandis apply for determining eligibility for earning increments subsequent to the first date of admission of a post into the fold of grant-in-aid. Provisions of the Orissa Service Code relating to payment of subsitence allowance shall mutatis mutandis apply to an employee holding an aided post who is placed under suspension by the competent authority provided that approval of Director has been obtained within the period stipulated in the relavant Rules.

Illustration :

- (a) An approved post in an educational institution notified as an Aided Educational Institution coming An approved post in an educational institution notified as an Aided Educational Institution coming within Category II completes the qualifying period on 1-5-1993. The date of eligibility of this post will therefore be 1-6-1994. The scale of pay of the post as prescribed by the State Government is, say, Rs. 2,000—50—2, 500—100—3,500. The admissible salary cost on 1-6-1994 shall be Rs. 2,000 plus D. A. at the rates made applicable by the State Government. The post will be entitled to receive grant-in-aid at the rate of 1/3rd of this amount. Ordinariy the post will be eligible to earn two increments of Rs. 50.00 each on 1-6-1995 and 1-6 1996. With effect from 1-6-1996, the admissible salary cost shall be Rs. 2,100.00 plus D. A. as admissible and the post will be eligible to receive grant-in-aid at the rate of 2]3rd of this amount. amount.
- (b) An approved post admissible on the basis of workload and yardstick was first filled up on 1-1-1983. The post completes nine years on 31-12-1991. The college in which this post has been continuing received concurrence and affiliation from the session 1981-82. This post will be eligible to receive grant-in-aid from 1-6-1994 but at the rate of full salary cost at the initial stage of the scale of pay applicable plus D. A. as admissible on that pay.
- (2) The State Government's liability for payment of grant-in-aid towards salary cost of any admissible post in an Aided Educational Institution shall be limited to such amount as is admissible under the provisions of this order and if the entitlement of such an employee exceeds the amount payable as grant-in-aid for that post under the Order, it shall be the responsibility of the management of that Aided Educational Institution to pay the balance amount.
- (3) A teacher of an Aided Educational Institution who is borne in a common cadre shall on trasnfer be entitled to protection of grant-in-aid admissible for the post which he was holding and which he was entitled to receive prior to his transfer.

(12) Irreespective of the date of eligibility, no grant-in-aid shall be payble to Aided Educational Institutions falling within Category II and III for any period prior to 1-6-1994. Arrear payments towards grantin-aid admissible for posts in educational institutions falling within Category I, may subject to funds being available in the Budget for this purpose be made in such manner and such form as the State Government may determine from time to time.

(1) when more then one scale of pay are admissible for a post based on qualifications and/or experience, the higher scale of pay shall not be taken into account for computing the grant-in-aid if the grant-inaid is p. yble to a person who does not possess the quifications and/or experience required for the higher scale of pay and has not been selected for the post carrying the higher scale in accordance with procedures and selection process applicable.

(14) (1) No grant-in aid shall be admissible nor any grant-in-aid shall be paid for an approved, post if it is held by a person on promotion unless the promotion of the person is indeed for an approved post if it against that post has been approved by the Director or the Government, as the case may be. For purposes of this order, appointment of any person in a post carrying a scale of pay higher than the scale of pay of the post which he was holding shall be deemed to be a promotion.

- (2) For the perpose of this Order, any promotion to or from a teaching post shall require the approval of the State Government and any promotion to or from a non-teaching post another non-teaching post shall require the approval of the Director.
- (3) No approval to a promotion from a teaching post to another teaching post or placement under career advancement scheme shall be accorded after commencement of the Amendment Act except in accordance with the Government of Orissa, Education Department Resolution No. 9491-EYS., dated the 19th March 1990 :

Provided that any person who was validly receiving grant-in-aid on the basis of a scale admissible to a promotional post prior to commencement of the Amendment Act shall continue to receive grant-in-aid on the same scale unless otherwise in eligible for the same.

(15) The Governing Body of a Non-Government Educational Institution notified cr which applies for notification as an Aided Educational Institution shall furnish proposals in regard to the person or persons who is/are eligible to receive grant-in-aid against approved posts or posts eligible to be approved from time time indicating the full justification for the proposal. The Governing Body shall *inter alia* furnish information on the following :—

- (a) The full name and permanent address of the person/persons considered eligible to receive grant-in-aid against each approved post or post eligible for approval;
- (b) Full particulars of the post against which he/she is eligible to receive grant-in-aid including particulars relating to approval of the post ;
- (c) Whether the person belongs to S.C. or S.T.;
- (d) Date of birth as recorded in the Matriculation Certificate or School Leaving Certificate in case of persons who are not Matriculates;
- (e) Educational quification (s) indicating the year of passing of each examination, name of the School/College attended the Board/Council/University which conducted the examination, Division or Class obtained, percentage of marks/grade obtained (attested true copies of all certificates and mark sheets shall be appended):
- (f) Date of appointment ;
- (g) How selected with full particulars (copies of the advertisement issued inviting applications proceedings of meeting of the Selection Committee/Screening Committee etc. shall be furnished);
- (h) Whether any other person was appointed against that post at any time in the past with detailed reasons for their non-continuance in the post. In case of termination of services by the Management or resignation, full particulars along with copies of documents in support may be furnished;
- (i) Whether any other person as or may have a claim for receiving grant-in-aid against the post if so, full particulars may be furnished.

(16)(1) On receipt of a proposal from the Governing Body under Para. 15, the Director shall examine each case and if he is satisfied that the person proposed by the Governing Body is eligible to receive grant-in-aid against an approved post, he shall make an order to that effect. Where the Director is satisfied that a person proposed by the Governing Body is not eligible to receive grant-in-aid, his decision shall be communicated to the Governing Body. For the purpose of satisfying himself as to eligibility of a person to receive grant-in-aid, the Director may call for any information, clarification or document that he considers necessary for the purpose

(2) No person shall be eligible to receive grant-in-aid agaiust an aided post unless-

(i) he has been lawfully and validly appointed to that post by the competent authority in accordance with the law, rules and instructions in force at the time of his appointment and has been continuing to hold that post on and beyond the date of eligibility of the post to receive

(ii) he possessed educational qualifications and experience required for holding that post at the time of his recruitment or on the date the post was admissible to grant-in-aid, whichever

(17) The liability of the State Government to provide grant-in-aid shall be limited to payment of grant-in-aid to one person against one eligible post at any time.

Illustration-

'A', a Lecturer in English has received grant-in-aid against one eligible post of Lecturer in that subject from 1-6-1994.

'B', a Lecturer in English who was holding that post prior to appointment of 'A' was dismissed or removed from service illegally.

Following the reinstatement of 'B' the State Government will only be liable to disburse the grant-in-aid to 'B' prospectively from the date of his resumption of duty following his reinstatement and Shall not be liable for payment of any grant-in-aid for the period peior to his resumption of duty if grant-in-aid has already been paid to 'A' for that period. Nor will Government be liable to continue payment of grant-in-aid to 'A'. The liability for payment of arrears to 'B', if any, shall be met by the Governing Body from the other funds of the Educational Institution concerned. other funds of the Educational Institution concerned,

18) In regard to teaching posts in an Aided Educational Institution coming under Category-II or III. the maximum number of subjects in respect of which grant-in-aid may be admissible shall be limited to the number of subjects as per yardstick prescribed in Annexure III. No. grant-in-aid would be abmissible for any teaching or non-teaching post which is not justified on the basis of workload, does not conform to the yardstick and has not been approved by the Director. Condi-tions specified in Annexure III with regard to admissibility of teaching and non-teaching posts as per yardstick shall be deemed to be conditions imposed by this order.

(19) When any person holding an aided non-teaching post is promoted to a non-teaching post in the same line in the same educational institution carrying a higher scale of pay and the promotiona post has not qualified for being declared as an aided post or is receiving aid at a lower rate than the post from which promotion is proposed to be given, as a special case, the person holding the iower post will on promotion be allowed grant-in-aid against the higher post at the same rate atwhich he was receiving grant-in-aid in the lower post and the lower post shall qualify for grant-in-aid at different rates the date special case, the person holding the lower post will on promotion be allowed grant-in-aid against the higher post at the same rate at which he was receiving grant-in-aid in the lower post and the lower post shall qualify for grant-in-aid at different rates from the date that the promotional post would have otherwise qualified for grant-in-aid but for this arrangement.

Explanation:-

Posts of Junior Clerk-cum-Typist, Senior Clerk and Head Clerk are posts in the same line.

Post of Assistant Librarian and Librarian are posts in the same line.

Illustration: -

'A', a Junior Clerk holds an aided post and is receiving grant-in-aid at the rate of 2/3rd or the admissible salary cost. A post of Senior Clerk which is in the same line admissible for that Aided Educational Institution but has not qualified for receiving grant-in-aid. 'A', on promotion to the rank of Senior Clerk will received grant-in-aid at the rate of 2/3rd of admissible salary cost as Senior Clerk and post of Junior clerk which he was holding will be treated as an unaided post. The post of Jr. Clerk would qualify for grant-in-aid as and when the post of Senior Clerk would have otherwise qualified for grant-in-aid.

(20) Whenever any Aided Educational Institution makes any new appointment including appointment by way of promotion, it shall report the fact to the Director within 15 days of making such appointment.) The report to the Director shall indicate the name or names of persons appointed the post against which such appointment has been made, whether such appointment has been made day direct recruitment or by way of promotion, the educational qualification and experience of the person so appointed and the reasons of coccasion for such appointment. The Director may prescribe the Pro forma in which such report be made.

(21) Where an order has been made by the Government or the Director irrespective of whether such order relates to notification of a Non-Government Educational Institution as an Aided Educational Institution, approval of any post, eligibility of any post to receive grant-in-aid, determination of the person who is eligible to receive grant-in-aid against an eligible post or any other matter on the basis of incorrect, false or concealed information, such order shall be liable to be cancelled or modified and any unwarranted payments already made shall be liable to be recovered from the Governing Body out of the funds of the concerned educational Institution.

(22) Notwithstanding anything contained in this order, where any person has been declared to be entitled to receive grant-in-aid or to receive grant-in-aid at a particular rate in pursuance of any Judgement pronounced or Order made by any Court prior to the date of commencement of the Amendment Act, such person shall be eligible to receive grant-in-aid in accordance with such Judgement or Order for the period prior to commencement of the said Act and payment of grant-inaid for any period thereafter shall be regulated by this Order.

23. If any question arises relating to the interpretation of any provision of this Order, it shall be referred to Government for decision which shall be final.

24. For removal of difficulties, the State Government may issue such general or special orders, not inconsistent with the provisions of the Act or of this Order, as may be necessary from time to time.



No. 30394—HE-FE-IV(A)-POL-0085/2014-HE.—In exercise of the powers conferred by sub-section (4) of Section 7-C of the Odisha Education Act, 1969, the State Government do hereby make the following order to regulate payment of Grant-in-Aid in shape of Block Grant to private educational institutions or for any post or to any person employed in such institution being a Non-Government College, Junior College or Higher Secondary School as specified hereunder, namely :—

1. Short title, application and commencement—

(1) This Order may be called the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-Aid in the shape of Block Grant Order, 2014.

(2) It shall apply to the Non-Government Colleges, Junior Colleges and Higher Secondary Schools.

- (3) This Order shall come into force with effect from the 1st day of January 2014.
- 2. (1) In this Order, unless the context otherwise requires,-
- (a) "Act" means the Odisha Education Act, 1969 (Odisha Act 15 of 1969);
- (b) "Amendment Act" means the Odisha Education (Amendment) Act, 1994 (Odisha Act 13 of 1994);
- (c) "Council" means the Council of Higher Secondary Education, Odisha, constituted under the Odisha Council of Higher Secondary Education Act, 1982;
- (d) "Director" means the Director, Higher Education, Odisha and includes any officer not below the rank of Deputy Director who may be authorised by the Government on that behalf from time to time by a general or special order, to perform all or any of the functions and exercise all or any of the powers on behalf of the Director under this Order;
- (e) "Educationally Backward District" means a district, where rate of literacy is less than 50 per cent of the total population of the district as per the Census of 2011;
- (f) "Government" means the Government of Odisha in the Higher Education Department;
- (g) "Governing Body" means a Governing Body constituted in accordance with the Act and the Odisha Education (Establishment, Recognition and Management of Private Colleges)

Rules, 1991 or the Odisha Education (Establishment, Recognition and Management of Private Junior Colleges/Higher Secondary Schools) Rules, 1991 as the case may be;

- (h) "Non-Government Educational Institution" means any educational institution which is not established and/or managed by Government of Odisha, the Union Government or the Government of any other State and does not include for purposes of this Order, any educational institution established or managed by any Corporation, Municipality or Notified Area Council, Zilla Parishad, Panchayat Samiti or any Grama Panchayat or any Public Sector Undertaking or Company or Statutory Body;
- (i) "University" means the Utkal University, the Berhampur University, the Sambalpur University, the Fakir Mohan University, the North Odisha University and the Ravenshaw University as the case may be; and
- (j) "Women Educational Institution" means a Women's Junior College or Degree College, which is imparting education exclusively to women students.

(2) All other words and expressions used but not defined in this Order, unless the context otherwise requires, shall have the same meaning as respectively assigned to them in the Act.

3. (1) The following Non-Government Educational Institutions shall only be eligible for consideration for Block Grant for being notified as Aided Educational Institutions under Clause (b) of Section 3 of the Act, namely :—

- (i) Higher Secondary Schools or Junior Colleges recognised by Government and affiliated to the Council imparting instruction and presenting regular candidates for Higher Secondary Examinations in Arts, Science or Commerce streams conducted by the said Council.
- (ii) Colleges recognised by the Government and affiliated to any of the Universities imparting instruction and presenting regular candidates for the +3 Arts, +3 Science and +3 Commerce Degree Examinations of the Utkal University, Berhampur University, Sambalpur University, Fakir Mohan University and North Odisha University with or without Honours.
- (iii) The Colleges or Junior Colleges or Higher Secondary Schools established, with recognition of the Government and affiliated to the Council or University, on or before the 1st June 2008 in respect of Educationally Advanced Districts, on or before the 1st June 2010 in Educationally Backward Districts and on or before the 1st June 2010 in respect of Women's Colleges in any district.

(2) The educational institutions referred to in sub-para (1) and its teaching and non-teaching staff are eligible to get 40% Block Grant with effect from the date of commencement of this Order, 60% Block Grant after completion of 03 years, 75% after completion of 06 years and 100% after completion of 08 years to be determined in the manner specified in Paragraph 14.

(3) The teaching and non-teaching staff of the Non-Government Aided Colleges which are covered under the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-Aid, 2008 and the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2009 who joined on or before the 1st June 2008 in respect of Educationally Advanced Districts and on or before the 1st June 2010 in respect of Educationally Backward District and Women's Educational Institutions are also eligible to get 40%

Block Grant, 60% Block Grant after completion of 03 years, 75% after completion of 06 years and 100% after completion of 08 years to be determined in the manner specified in Paragraph 14 :

Provided all such appointment of teaching and non-teaching staff must have been as per prescribed norms and against the posts permissible as per approved yardstick for the said institutions.

(4) No educational institutions, established or managed by any Corporation, Municipality or Notified Area Council, Zilla Parishad, Panchayat Samiti or any Grama Panchayat, any Public Sector Undertaking or Company or Statutory Body, the Union Government or the Government of any other State, shall be eligible to get any aid under this Order.

(5) No order according permission or approval or recognition either temporary or otherwise under the relevant provisions of the Act, or under any rule applicable to it, and no order of any University or the Council according affiliation, whether such permission, approval, recognition or affiliation was accorded prior to the commencement of the Amendment Act, or thereafter shall *ipso facto* entitle any Non-Government Educational Institution to be notified as an Aided Educational Institution or to receive Grant-in-Aid for any post.

4. (1) The educational institutions to be considered for Grant-in-Aid in shape of Block Grant in accordance with this Order should have received recognition and affiliation for each course, stream and subject taught in that institution for each academic year for a continuous period of minimum 5 years in respect of Educationally Advanced District and 3 years in respect of Educationally Backward District and a Women's Educational Institution without any break or discontinuity from the date of establishment :

Provided that, in case of break or discontinuity, to acquire eligibility, the said qualifying period shall be computed from the date of revival.

(2) The educational institution has maintained correct record of admissions, attendance of students, accounts of receipts and expenditure and acquaintance rolls of salary and other allowances paid to teaching and non-teaching employees of the institution.

(3) The educational institution has a Governing Body duly constituted and approved in accordance with the prescribed rules.

(4) The Governing Body of the educational institution has submitted an application in the prescribed form complete in all respects within the period specified and in accordance with the procedure laid down in this Order.

(5) The educational institution has fulfilled all the criteria and the Director has recommended such institution to be notified as an Aided Educational Institution.

5. A Non-Government Educational Institution found eligible under Para. 3(1) and Para. 4 shall be notified to be an Aided Educational Institution by the Government. No post in any educational institution which has not been notified by the State Government as an Aided Educational Institution under the Act shall be eligible or to receive Grant-in-Aid from the Government under this Order.

6. (1) A Non-Government Educational Institution eligible to be and desirous of being notified as a Non-Government Aided Educational Institution shall make an application to the Director in the Form 'A' appended to this Order, at Annexure I together with copies of documents specified therein within such period as specified hereinafter. The application shall be made and signed jointly by the President and the Secretary of the Governing Body and shall *inter alia* be accompanied by :—

- (a) an affidavit attesting to the correctness of the facts and statements made in the application and authenticity of copies of documents attached thereto;
- (b) a resolution of the Governing Body requesting Government to notify the applicants institution as an Aided Educational Institution and agreeing to abide by the provisions of this Order and also to such conditions as may be specified for sanction and utilisation of the aid.

(2) An application in the prescribed format as at Annexure I shall be made within one month from the date of notification of this Order in Official Gazette. The Director my for good and sufficient reasons extend the period within which the application may be made by such period as he deems fit but not exceeding three months in total. No application received thereafter shall be taken into consideration.

(3) On receipt of an application the Director shall inspect or cause the Applicants Educational Institution to be inspected and take such measures as may be necessary to satisfy himself about the eligibility or ineligibility of that educational institution for being notified as an Aided Educational Institution. The Director may cause the accounts of the Applicant Institution to be audited and call for such further records, documents and evidences as in his opinion are required for establishing the eligibility of the Applicants Institution for being notified as an Aided Educational.

(4) After completion of enquiry, the Director shall report to the State Government the facts and circumstances in which the Applicants Institution has been found eligible or not eligible and shall also make recommendation in respect of each Applicants Institution.

7. A Non-Government Educational Institution, which is to be notified as an Aided Educational Institution in accordance with this Order shall not *ipso facto* be eligible to receive Grant-in-Aid. Such an institution will only be eligible to receive Grant-in-Aid in shape of Block Grant towards 40% of salary cost of the approved teaching and non-teaching posts in that Institution, which are eligible to receive Grant-in-Aid in accordance with the provisions of this Order. The balance salary cost of these posts shall be borne by the Governing Body or Managing Committee of the Institution.

8. (1) A post in a Non-Government Educational Institution for which no Grant-in-Aid has been sanctioned prior to commencement of this Order shall be eligible for Grant-in-Aid in shape of Block Grant, if,—

- (a) the post is admissible as per work-load and yardstick prescribed in this Order at Annexure II; and
- (b) it has completed qualifying period of 5 years or more from the date of its admissibility or of 3 years or more in the case of an educational institution situated in an Educationally Backward District or in case of a Women's Educational Institution.

(2) The workload for determining admissibility of a post shall be computed by taking into account the total workload on account of Degree Course and Higher Secondary Course in all streams conducted in that Institution. If a question arises as to whether a post is admissible on the basis of workload/or yardstick, the decision of the Director thereon shall be final.

(3) The workload shall be determined with reference to the actual enrollment during the academic year in which the post is admissible, limited to the strength of students for which recognition

and affiliation has been received and the number of candidates presented at the Higher Secondary or the Degree examination, as the case may be, from the same batch of students.

(4) A post shall not be deemed to have completed the qualifying period unless,-

- (a) the post has been filled up on full time basis during the entire qualifying period;
- (b) the post has not been filled up on honorary or part-time basis at any time during the entire qualifying period;
- (c) the post has been filled up by a person or persons recruited in accordance with the procedure laid down in the Act, Rules and instructions as applicable at the relevant time;
- (d) the post has been filled up at all times during the qualifying period by a person duly qualified to hold such a post.

(5) Application for approval of posts, which are eligible for approval, and application for notification of that educational institution as an Aided Educational Institution shall be made simultaneously in the prescribed 'Form-A' appended to this Order at Annexure I. Where the Director is satisfied that a post is eligible for approval, he shall issue an order to that effect with prior concurrence of the State Government indicating the date from which the post has been approved.

(6) The date of eligibility of a post for which Grant-in-Aid in shape of Block Grant has not been sanctioned shall be the first day of the academic year following the date on which an approved post completes the qualifying period as applicable to the post :

Provided that the date of eligibility in respect of a post in an educational institution shall in no case be a date after the 1st June 2008 in Educationally Advanced District and be a date after the 1st June 2010 in Educationally Backward District and Women's Educational Institution.

9. Grant-in-Aid in the shape of Block Grant payable to an Aided Educational Institution shall be the sum total of Grant-in-Aid admissible towards salary cost at the rate specified in this Order for each admissible and approved post from and after the date of eligibility and the Block Grant so payable shall be disbursed directly to the incumbents validly appointed and holding the post eligible for Grant-in-Aid, either by the Director or through any other agency so authorised by the Government. The Government may from time to time determine the mode and form of disbursement.

10. The Governing Body of a Non-Government Educational Institution notified or which applies for notification of such institution as an Aided Educational Institution shall furnish proposals in regard to the person or persons who is or are eligible to receive Block Grant against approved post or posts eligible to be approved from time to time indicating the full justification for the proposal. The Governing Body shall *inter alia* furnish information on the following :—

- (a) The full name and permanent address of the person or persons considered eligible to receive Block Grant against each approved post or posts eligible for approval;
- (b) Full particulars of the post against which he or she is eligible to receive Block Grant including particulars relating to approval of the post;
- (c) Whether the person belongs to S.C. or S.T.;
- (d) Date of birth as recorded in the Matriculation Certificate or School Leaving Certificate in case of persons who are not Matriculates;

- (e) Educational qualification(s) indicating the year of passing of each examination, name of the School or College attended the Board/Council/University which conducted the examination, Division or Class obtained, percentage of marks or Grade obtained (attested true copies of all certificates and mark sheets shall be appended);
- (f) Date of appointment;
- (g) The mode of selection with full particulars (copies of the advertisement issued inviting applications, proceedings of meeting of the Selection Committee or Screening Committee shall be furnished);
- (h) Whether any other person was appointed against that post at any time in the past with detailed reasons for their non-continuance in the post. In case of termination of services by the Management or resignation, full particulars along with copies of documents in support may be furnished;
- (i) Whether any other person has or may have a claim for receiving Block Grant against the post, if so, full particulars may be furnished.

11. (1) On receipt of a proposal from the Governing Body, the Director or any officer authorised by the State Government shall examine each case and if they are satisfied that the person proposed by the Governing Body is eligible to receive Block Grant against an approved post, he shall make an order to that effect. Where the Director is satisfied that a person proposed by the Governing Body is not eligible to receive Grant-in-Aid in shape of Block Grant, his decision shall be communicated to the Governing Body. For the purpose of satisfying himself as to eligibility of a person to receive Grant-in-Aid in the shape of Block Grant, the Director may call for any information, clarification or document that he considers necessary for the purpose.

(2) No person shall be eligible to receive Block Grant against an aided post unless,-

- (a) he has been lawfully and validly appointed to that post by the competent authority in accordance with the Act, Rules and instructions in force at the time of his appointment and has been continuing to hold that post on and beyond the date of eligibility of the post to receive Grant-in-Aid in the shape of Block Grant; and
- (b) he possessed educational qualifications and experience required for holding that post at the time of his recruitment or on the date the post was admissible to Grant-in-Aid, whichever is later.

12. The liability of the State Government to provide Grant-in-Aid in shape of Block Grant shall be limited to payment to one person against one eligible post at any time.

13. Where an order has been made by the Government or the Director irrespective of whether such order relates to notification of a Non-Government Educational Institution as an Aided Educational Institution, approval of any post, eligibility of any post to receive Block Grant, determination of the person who is eligible to receive Grant-in-Aid against an eligible post or any other matter on the basis of incorrect, false or concealed information, such order shall be liable to be cancelled or modified and any unwarranted payments already made shall be liable to be recovered from the Governing Body out of the funds of the concerned educational institution.

14. The Block Grant payable to the private institution under Paragraph 7 shall be a fixed sum of Grant-in-Aid, which shall be determined not exceeding 40% of the Initial Pay + Grade Pay (as per

O.R.S.P. Rule, 2008) applicable to the employees as admissible prospectively of the teaching and non-teaching employees to the education institution which has become eligible to receive Grant-in-Aid by the 1st day of June, 2013.

15. Whenever any Aided Educational Institution makes any new appointment including appointment validly and lawfully by way of promotion, it shall report the fact to the Director within 15 days of making such appointment. The report to the Director shall indicate the name or names of persons appointed, the post against which such appointment has been made, whether such appointment has been made by direct recruitment or by way of promotion, the educational qualification and experience of the person so appointed and the reasons occasion for such appointment. The Director may prescribe the *pro forma* in which such report to be made.

16. If any question arises relating to the interpretation of any provisions of this Order, it shall be referred to the Government for decision, which shall be final.

17. For removal of difficulties, the State Government may issue such general or special orders, not inconsistent with the provisions of the Act or of this Order, as the case may be necessary from time to time.

1. (i) Maximum number of students other than compulsory subjects in which admissible post of teachers will be eligible for approval for purposes of Grant-in-Aid in shape of Block Grant shall be as indicated in the Table below :—

(ii) One post of Lecturer for each compulsory subject will be admissible unless more posts are justified on the basis of workload and on the basis of yardstick hereinafter provided. When the same compulsory subject it taught as a compulsory subject or optional subject many other stream or course, number of teachers will be determined on the basis of the total workload in that subject for all courses and streams taken together in the same educational institution.

(iii) Where an Aided Educational Institution has received recognition and affiliation for more optional subjects as admissible on the basis of Column 4 of the Table in Para. 1 the number of optional subjects for which teachers will be admissible shall be limited to the number indicated in Column 4 and teachers in remaining subjects shall not be eligible for approval. In these circumstances the subjects in which posts of teachers shall be approved it shall be based on the number of students actually admitted and enrolled and continue appearing the examination taking an average of preceding three years of the institution to be notified as an Aided Educational Institution.

Illustration : A college has received recognition and affiliation for 128 students and 6 optional subjects. The actual enrollment in the College is 64, it would therefore be eligible for approval of teachers in four subjects and not in six subjects. The average in each of the sixth subjects

during the 5 years preceding the date of its eligibility in notification as an Aided Educational Institution was as follows :----

In this example subjects like B, C, D and E having the highest enrollment will be selected as the 4 optional subjects in which teaching posts will be eligible for approval. No post of teacher for subject like A, F will be eligible for approval.

(iv) Additional post of Lecturers for optional subjects will be admissible on the basis of workload assessed with reference to the yardstick indicated hereinafter and for purposes of determination of the total workload. The workload on account of the Higher Secondary Course and Degree Course in all streams in that subject shall be taken together provided that the Higher Secondary wing and the Degree wing of that institution have both been notified as Aided Educational Institutions.

Illustration : A General College has received recognition and affiliation for subjects 'A', if subject 'A' is a compulsory subject for all students and is also an optional subject for some students. The total number of classes for the compulsory subject is 25 per week and the total number of classes in this subject as optional subject is 12 per week. Since the total workload is 37 per week two teachers would be eligible for approval. Two years later the same institution receives recognition and affiliation for opening of Degree Course in Arts where this subject is taught as one of the optional subjects. The total number of classes per week. The total workload in that subject in that educational institution after notification of the Degree wing as an Aided Educational Institution therefore, comes to 49. No more post of Lecturer would be admissible on the basis of workload.

(v) One post of Lecturer would be admissible for 25 periods per week in that subject in that Aided Educational Institution but no post of additional Lecturer shall be admissible if the total period does not exceed 25 or multiple of 25 by 20 per cent.

Illustration : Total number of periods to be taken in a subject whether as a compulsory subject or as an optional subject is 80. Three posts of Lecturer will be admissible.

Fourth post will be admissible only when the total number of periods to be taken exceeds 90, i.e., 75 plus 20 per cent of 75 :

Provided that if the number of students admitted to the Honours Course in any subject is less than 8 or the number of students offering any optional subject is less than 16 in any year the workload on account of such subject shall not be taken into account for computing the workload in that subject for that year.

3. In a subject having practical one post of Laboratory Assistant shall be admissible for every 36 periods of practical in a week. No additional post of Laboratory Assistant shall be admissible if the total number of practical periods does not exceed 36 or multiples thereof by 10 per cent.

NOTE : A practical period for this shall be counted as one period irrespective of the number of students in the group. When 32 students in a practical group meet in one practical class of 3 periods, it shall be counted as 3 periods, but not as 6 periods by assuming 16 students in each group :

Provided that not more than one post of Laboratory Assistant shall be admissible for approval for subject like Geography, Geology, Anthropology, Psychology, Home Science and Education irrespective of the number of periods of practical per week.

4. One post of P.E.T. shall be eligible for approval for every Aided Educational Institution. Where a Junior College or Higher Secondary School and a Degree College have been separately notification Aided Educational Institution, but functioning as two wings of the same institution, one post of P.E.T. would be eligible for approval for both the Higher Secondary wing and the Degree wing of that institution.

If any teaching or non-teaching post is required in an Aided Educational Institution beyond what is admissible as mentioned above the salary and non-salary costs of such posts shall be borne by the Governing Body and the State Government shall bear no liability for the same.
