Article One

Udayanath Autonomous College of Science and Technology and Chetana College of Special Education shall endeavor to exercise their best efforts to develop the following forms of cooperation through online or physical visit method for Clinical Psychology and related disciplines.

- 1. Conduct of faculty development programme, staff development programme, seminars, conferences, workshops, parent counselling, educational counselling and clinical programmes in joint collaboration.
- 2. Develop collaborative research programmes and joint publications.
- 3. Conduct of need-based student development activities in joint consultation and mutually agreed condition.
- 4. Conduct social outreach activities.
- 5. Allow faculties to guide research students at M.A. and Ph.D. level subject to the rules and regulations of the concerned Universities.

Article Four

This Memorandum of Understanding becomes effective on the date of its signing by the authorized representatives of both the institutions. It shall be effective for five years and reviewed prior to renewal.

This Memorandum of Understanding may be terminated by either party upon six months written notice to the other party. However, in case a decision is taken to terminate the MOU, any on-going project shall not be stopped till it is completed.
