Established in 1991, Udayanath Autonomous college of Science and Technology, Adaspur, Cuttack stands as a prominent government-aided private institution renowned for its robust infrastructure and commitment to STEAM education. The college holds recognition under sections 2(f) and 12(B) of the UGC Act, 1956, underscoring its academic credibility. It offers Arts, Science, and Commerce undergraduate courses since the early 1990s, with Honours programs introduced in 1996. The college features 25 Honours subjects, including Women's Studies and offers postgraduate programs in Commerce from 2009.

Spread across 30 acres, with a vibrant academic environment, offering a wide range of undergraduate and postgraduate programs in sciences, social sciences, and humanities. With a student body of 4292 in the current session, Udayanath autonomous college maintains a balanced gender ratio with 60% female and 40% male students.

**2.2 Catering to Student Diversity****2.2.1**

**The institution assesses the learning levels of the students and organises special Programmes to cater to differential learning needs of the student**

**Response:**

Different strategies are adapted in the institutional level to support the slow learners. First of all the slow

learners are identified by mentoring system, physiological tests and counseling at the time of entry into the institution. Each students' learning needs, strengths ,weaknesses are identified to prepare a teaching plan before commencement of mid -term examination .Considering the performance of students and recommendation of concerned teachers ,slow and advanced learners are identified. Slow learners have slow sensory motor development and more reactions in time leading to defect in vision, hearing and speech. By observation method, case study method, medical examination and scholaristic tests, slow learners are identified. Then they are assigned to a particular mentor to undertake various initiatives continuously like peer learning, special class, tutorial, problem solving, language training, basic communication courses and effective counseling. Remedial instructions, motivations, healthy environment, periodical medical checkup and individual care are provided to each slow learner.

Slow learners are paired with good performers to enhance their learning abilities (Peer group learning)

The soft and communication skills are given special emphasis for the students from rural Backgrounds to improve these skills and thereby bring them to par with regular learners. Conduct additional tutorial classes for improving the student's knowledge

The advanced learners are identified taking into account the involvement of the students in the class rooms and result sheets of concerned examinations. They are taken care by providing question bank, providing more skill courses. Encouraging them for self directed projects and research based on their interest and abilities. They are provided with books, articles and resources at a higher level of complexity. Advance learners are the brand ambassador of the institution groomed by the department through participation in conference, skill training, web development and peer teaching. Institution always tries to engage them in learning by providing reading room facilities with well maintained libraries. Different varieties of recent articles and publications are available in reading room to enrich the knowledge of advance learner in every field as well as the field of interest of the students. Our institution provides e-library by which the students can easily avail the books with fewer difficulties. Proctors motivate them for self -directed learning by identifying the resources and online courses. Students are motivated to apply their learning in their real life situation because practical experience is essential for mastery. Our institution has set up well equipped laboratories with good and advance equipment for science practicals. Our institution tries to engage them in teaching or mentoring others by student seminars which can deepen their understanding and reinforce the knowledge. #### **Response:**

The teacher is not the teacher only in the classroom but a mentor and a guide. The mentoring system is undertaken in the campus with the help of mentor and mentee through which there is the sharing of student interest, academic goals or personality test. The mentor is the father confessor and the mentee mostly confess the details of their strength and weaknesses to the mentor, who in term will try to alleviate their sorrows, grievances or complains through advice and proper guidance. The objective of this system is to develop a cordial relation between teacher and students. Participation in the academic and administrative issues that enable them to build capacities which promote student and Institution wellness. These cordial relations have been fruitful in terms of maintaining a green campus zero student unrest, participation in various community Service Programmes, organization of various talks, awareness regarding environment, Constitutional values, gender sensitization, and human rights. Regular activities of different clubs.

Through the system mentors provide training to the mentees including active listening skills, empathy, conflict resolution and basic counseling techniques. This system helps to educate mentees on available academic and psychological resources. Through this process the institution set clear goals and expectation for the mentorship programme such as the frequency and duration of meeting and defines the scope of academic and psychological support that mentors can offer.

To achieve the goal frequent meetings are conducted between the mentors and mentees the meeting may be in person, via video call or through text message. Mentors assist the mentees with study strategies, time management and academic goal setting. Mentees are supported by listen their problems by giving emotional support and referrals to counseling services when necessary. Mentors focus on building mentees resilience and coping skills. Institution collects feedback from both mentors and mentees to assess the effectiveness of the programme and also make effective decisions based on feedback to continuously improve the system. Examination periods and dates are set by creating a balanced exam schedule to avoid back to back examinations for students. Once the calendar is finalized it is approved by IQAC in its general meeting considering various guidelines of Department of

Higher Education of Government of Odisha. At the department level the department calendar of academic activities is prepared. The time table is prepared at the beginning of every semester. The teaching learning strategies of various programmes are planned during department meeting. At teacher level course allocation is done considering faculty preference and expertise. Course plan is a detailed schedule of teaching plan prepared by the respective course teacher in accordance with the format provided by the IQAC. The approved teaching plan is submitted to IQAC. Teaching plans include lesson plan, lesson notes, laboratory manuals and study materials. The academic planners focus on preparation of question bank on each programme and each course.

Our institution ensures that the academic calendar is adhering to with a strong commitment from all parties including faculty, staff and students. The institution regularly reviews the calendar to identify any deviations and adjust as necessary. Any changes or updates to the calendar are informed to all stakeholders. Udayanath Autonomous college of Science and Technology, is raising its value high by creating and enhancing qualitative and effective teaching learning process. Adequate infrastructural facilities are available and are upgraded for effective teaching – learning & holistic development of the students. The UGC norms for infrastructure of classrooms, laboratory, library, recreation area and reading rooms have been fulfilled. The floor space, furniture, equipment, support system and ICT facilities meet the statutory facilities. The green campus of 30.62 acres has well planned facilities for academic and co-curricular activities.

#### **1. Classroom facilities**

There are 80 well –ventilated and spacious classrooms with ergonomic furniture to accommodate all the students. Accessibility to all floors is provided through broad staircases and corridors. Some classrooms are equipped with green boards, LCD projectors and LAN connectivity with ITC facilities. Notice boards are available in all the departments. Dustbins are provided for collecting segregated waste in all the classrooms. Wi-Fi access points in all floors of all the building enable connectivity during classes. The college has a total built up area of 369515 sqft out of which 75222 sqft were added from 2017 - 2022.

#### **2. Laboratories :**

Specialized labs across computer science, physics, mathematics, and psychology support data analysis, modeling, and equipment control. Equipped with safety measures, including showers and fire extinguishers, labs feature refrigerators and deep freezers (-20°C) for sample storage. Incubators maintain conditions for experiments and a telescope aids sky observation and community education on eclipses. About 20 labs serve UG and PG science, allied science, and social science departments.

#### **3. Computing Equipment :**

The college is executed through automated software in different sections like Accounts, Library, Examination Cell as well as Autonomous Cell. The students are provided with online payment system

along with online Exam form fill-up, Online admit card and online results. In-house Learning Management System (LMS) is a complete automation solution for academic activities that is implemented by the institution.

#### 4 . Facilities for sports and games :

Believing in the co-existence of a sound mind sound body, Uday Nath( Autonomous ) college has a specific organization for sports and games. The college has a mini stadium consisting of 12 acres of land named as “Prachi Gym Khanna and Stadium”. The stadium is provided with a pavilion of 900 capacity audience strength to watch sports. The stadium has the facilities for playing Cricket, football, volley, table, kho-kho, lawn tennis and table tennis .**The college has a swimming pool (50\*21m) where students practice swimming with the assistance of well-trained coaches.**

#### 5 .Other facilities :

The library is the primary learning resource of the college and it is automated through integrated library management system known as the “**e-Granthalaya**” software, developed by National Informatics Centre, Government Of India since 2012.The software consists of modules such as master data, data utilities, book acquisition, author directory, check duplicate title, add new title , received document accessioning , bill detail, payment detail, cataloguing, retro conversion, stock verifications, bar coding circulation. The library is equipped with separate spacious reading room with a sitting capacity of more than 500 students.

The library is a subscriber of **INFLIBENET (N-LIST)** which provides e-journals and e-books. The library is also getting facilities of databases from EBSCO provided by Higher Education Department, Government Of Odisha for Teachers and Students. The **Pandit Godabarisa Mishra Library** not only fulfills the need of the students and teacher but also fulfill the need of the researchers, members of the local community and the Alumni. . There is also a reference counter of Dissertations PG and UG students which will help them in their future research work. It also subscribes Twenty News Papers and Fourty Magazines in order to enhance the reading habit of the students and faculties.

The library extends support to the research and publications process of Faculty and Researchers. Library offers smart, professional and sustainable solutions to the institute’s existing and future research



environment, to position itself at cutting edge of technological development and contribute to the increased visibility, dissemination, conservation and evaluation of scholarly production.

The Library Constantly disseminates information regarding the facilities and programmes on the institutional website, e-mail, social media and mobile application. The smart Auditorium is equipped with latest ICT facilities to conduct Seminars with capacity of more than 300 students. The institution has multiple number of smart class rooms equipped with projectors and audio visual equipment. The college has an ICT facilitated conference hall for meetings and seminars with a capacity of more than 50 students. All computer labs are under high-speed secure LAN system with 24hrs internet facility along with proper fire extinguishers to avoid any accidental conditions.

The institution has updated computers i3 & i5 processors which are provided with adequate LAN facilities. The institution has 23 licensed software with scanning, Xerox facility and other peripherals.

The printer and peripherals are updated on a regular basis to keep up with the rapidly changing technology. In addition, the institution website <https://udayanathcollege.ac.in/> displays the details of the institution with courses offered, faculty, infrastructure, upcoming events in the individual departments and information of the well performed / awarded students. Power back up facility is available for all the systems are also maintained regularly. This audit maintains energy consumption, water usage, rain water harvesting, office waste management, solar power project, vehicle usage, monitoring air quality and other factors which influence the sustainability of the operation. Also, an evaluation of various existing initiatives, taken by the college to make the campus eco-friendly. The Greenery and beautification in the college is maintained by the Green Audit Team of the College.

For maintaining the aesthetic beauty of college, dedicated gardeners are employed. The institution has conducted plantation programme by NSS, NCC, and Scout & Guide etc. The college campus is surrounded by various trees like Ashoka, Neem, Pine, Coconut, Mango, Guava etc. It has number of lawns and five gardens which is supervised by the gardeners.

Recently, the college follows a tradition of gifting saplings instead of bouquets to the guests at various events. The College maintains a diverse flora to enhance its aesthetic beauty.

All classrooms, tutorial rooms and administrative blocks at each floor of the campus building have dustbins. Both biodegradable and non-biodegradable bins are used to segregate the waste.

The washrooms are properly and timely cleaned and equipped with amenities of soap, tissue dispensers, and liquid sanitizers. The institution has installed sanitary pad dispensers in girl's washroom. College promotes the use of eco-friendly phenyl for general cleaning purposes. The college building has naturally well-lit classrooms, staff rooms, offices and washrooms to minimize the usage of artificial light.

Udayanath Autonomous College of Science and Technology is gradually transcending to energy efficient LED lighting from the greater energy depleting fluorescent lighting. Copper wiring instead of aluminum wiring is used in the college to minimize the wastage of electricity. Air-conditioners (ACs) installed in the Staff rooms and administrative blocks are five-star rated, eco-friendly and are serviced twice a year by authorized technicians. The AC filters are cleaned on a regular basis by the college staff to improve performance and reduce greater energy usage.

##### **Best practice-I**

**Title of the Practice:** Proctorial System (Mentor-Mentee System)

**Objective of the Practice:** We have identified the following objectives that are in tune with the practice:

**Context:** Proctorial system was initiated in our college to maximize the teacher student relationship. This system functions through a participative style where both teachers and students actively engage to solve problems and issues. This is an effective monitoring system which helps to observe all activities, programs, progress, problems and issues throughout the academic year.

##### **The Practice:**

The teaching staff of the institution will be designated as proctor and each proctor is allotted around 20 to 25 students.

To meet the needs of mentee, the mentor conducts periodical meetings at the college premises for once a month.

The mentor establishes a good rapport with the mentee.

The mentor provides emotional support for the students in case of stress related problems, emotional problems, anxiety etc.

Uses Email, WhatsApp to encourage e-mentoring.

Facilitates the awareness of opportunities for the mentee regarding various career development resources.

Both Mentor and Mentee provide feedback and modifies the relationship, expectations and strategies as needed.

**Evidence of Success:** The proctorial system ensures that the curricular and co-curricular development of students go hand in hand. It addresses the issues of students with regard to discipline, code of conduct, co-curricular activities and thus focusing on holistic development of learners. The program also helped the teacher to thoroughly understand the students, his strengths and weaknesses, and the ability of the student to carry out what is planned. College stadium is open for morning walk for both boarder and outsider. Students practice different sports like volley ball, cricket, kabaddi, javelin throw, short put, discus, running, long jump, high jump etc. in the stadium. Both university and state level sports are organised by the Institution.

College students practice exercises in the college gym in morning and evening time.

A swimming pool inside the campus adds an extra brownie point to the amenities of the college. Swimming pool facility provides students with a recreational outlet, promotes fitness and serve as venue for local and university level swimming competition.

Replacing soft drinks with coconut water as welcome drinks for the guests

To stay fit both physically and mentally, morning starts with yoga practice in the college

Vermicompost produced in the waste management drive is used as fertilizer in the garden

Waste water is reused in the garden, swimming pool is cleaned at regular interval etc.

**3. Library facilities:** The institution has a good library having nearly twenty thousand books covering all disciplines which caters to the needs of the students including competitive exams. The library offers services which provide books, reference section, Magazines, Newspapers etc. It also offers E-library facilities for the faculties and students to make them techno-savvy. It provides the following services.
