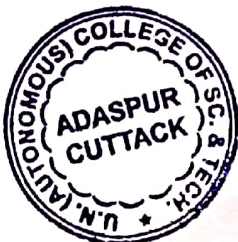
## Article Two




